

Privacy Policy

This Privacy Policy describes the current policies and practices of MOBILE ADVERTISING TECHNOLOGY LTD. with regard to Personal Data collected by MOBILE ADVERTISING TECHNOLOGY LTD. on its website, lpo6.com (the "Site"). "Personal Data" refers to personally identifiable information about You (such as your name, birth date, e-mail address, IP address or mailing address, phone number and any other information that can be used to identify or contact you).

1.0 What information do we collect?

We collect information from You when you register on our Site.

2.0 Personal Data Collected

The only Personal Data that MOBILE ADVERTISING TECHNOLOGY LTD currently collects is the data that You voluntarily provide to Us for our services. There are several places on the Site where you may enter Personal Data to receive information or services from MOBILE ADVERTISING TECHNOLOGY LTD.

3.0 What do we use Your information for?

With Your Consent

We will share personal information outside of MOBILE ADVERTISING TECHNOLOGY LTD when we have your consent.

For External Processing

We provide personal information to our affiliates and other trusted businesses or persons to process it for Us, based upon Our instructions and in compliance with our Privacy Policy and any other appropriate confidentiality and security measures.

For Legal Reasons

We will share personal information outside of MOBILE ADVERTISING TECHNOLOGY LTD if we have a good-faith belief that access, use, preservation or disclosure of the information is reasonably necessary to:

- Meet any applicable law, regulation, legal process or enforceable governmental request.
- Enforce applicable Terms of Service including investigation of potential violations.
- Detect, prevent or otherwise address fraud, security or technical issues.
- Protect against harm to the rights, property or safety of MOBILE ADVERTISING TECHNOLOGY LTD, our users or the public as required or permitted by law.

4.0 Non-Personal Data Collected

Data that does not qualify as Personal Data because it cannot be used to contact or identify You ("Non-Personal Data") may also be automatically collected. For example, Ipo6.com and its business partners may use technology to automatically collect Non-Personal Data about the use of the Site. This technology is used to track how many users access the Site, the date and time of their visits, the length of their stays, and which pages they view. We may also use technology to determine which web browsers You use. The information collected using this technology does not identify any user personally and is thus Non-Personal Data that simply enables MOBILE ADVERTISING TECHNOLOGY LTD and its business partners to compile statistics about users and their use of the Site. We use this Non-Personal Data and may share it with third parties to improve the content and functionality of the Site, to better understand our customers and markets and to improve our products and services.

5.0 3rd Party Advertising

We may use third party advertising companies to serve ads for us, using Non-Personal Data. These third parties may employ cookies and action tags (also known as single pixel gifs) to measure

advertising effectiveness. They may also use this technology to serve specialized or relevant advertising content and/or recommendations to you on the Site or on a third party's website. Any

information that these third parties collect via cookies and action tags is anonymous and does not contain any Personal Data. We don't show you personalized ads based upon sensitive categories such as race, religion, sexual orientation or health.

6.0 What is a "3rd party ad network?"

Many of the banner ads displayed on web pages are not selected and delivered by the website visited by a consumer but by network advertising companies that manage and provide advertising for numerous unrelated websites. These companies are referred to as "**3rd party ad networks.**"

We may share Non-Personal Data and with 3rd party ad networks to improve the content and functionality of websites, to serve relevant advertising messages and measure advertising effectiveness, to better understand our customers and markets, and to improve our products and services. Authorized 3rd party networks are contractually bound to secure the Non-Personal Data we transfer.

7.0 Do we use cookies?

Yes. Cookies are small files that a site or its service provider transfers to Your computer's hard drive through Your web browser (if you allow it to) that enables the site's or service provider's systems to recognize Your browser and capture and remember certain information.

We use cookies to help us understand and save your preferences for future visits, keep track of advertisements and compile aggregate data about Site traffic and Site interaction so that we can offer better Site experiences and tools in the future.

8.0 Do we disclose any information to outside parties?

MOBILE ADVERTISING TECHNOLOGY LTD may disclose Personal Data to third parties if You have requested that we do so, or if it is necessary to provide you with the services you requested.

If MOBILE ADVERTISING TECHNOLOGY LTD is acquired by or merged into another entity, or all or a portion of MOBILE ADVERTISING TECHNOLOGY LTD's assets are sold or otherwise transferred to another entity, MOBILE ADVERTISING TECHNOLOGY LTD may disclose Personal Data to that entity. MOBILE ADVERTISING TECHNOLOGY LTD may also disclose Personal Data if required or authorized to do so by law, pursuant to a court order or to an industry reporting authority.

9.0 Third Party Links

Occasionally, at our discretion, we may include or offer third party products or services on our Site. These third-party sites have separate and independent privacy policies. In certain circumstances, we may also report the violation to appropriate authorities.

You may be required to provide identifying information and/or answer some security questions to verify your identity.
